Introduction

- Safety is a priority for organizations.
- Human error is a leader cause of safety risks, safety incidents, accidents, and injuries.
- The traditional approach to safety and a search for something new...
- Safety Citizenship Behaviors are similar to Organizational Citizenship Behaviors expect that they are focused on improving the safety performance of other team members and the organization (Didla, et al., 2009)





What is Safety Citizenship Behavior?

- "Behaviors that are discretionary, not directly or explicitly recognized by the formal reward system, and that in the aggregate promote the effective functioning of the organization." (Didla et al., 2009)
- Acts that go beyond one's formally prescribed duties.
- A proactive approach to risk management
- SCB allows employees to use their discretion with respect to safety of their work which in turn is likely to increase their safety consciousness.

Safety Citizenship Behavior

A higher-order construct consisting of various behaviors

- Stewardship
- Voicing One's Opinions
- Helping Co-Workers
- Whistle-Blowing
- Initiating Workplace Change
- Civic Virtue

The Role of Safety Citizenship in Traffic Safety

- Transportation and organizations have followed a similar path.
- Growing traffic safety citizenship by everyone is a strategic shift which focuses on the engagement of the larger majority of safe road users to influence the behaviors of the smaller risk group.

<u>Definition:</u> Traffic safety citizenship behaviors are discretionary, extra-role behaviors that together contribute to the individual and collective safety of all road users.
