Ralph Wetterhahn to Speak at **Montana Aviation Conference**

Aviation archaeologist Ralph Wetterhahn will be one of three keynote speakers during the upcoming 2024 Montana Aviation Conference in Butte. Ralph has become a real-life "Indiana Jones", traveling the world from Cambodia to the Russian Far East, Guadalcanal, and the Philippines in search of aircraft wrecks, our nation's missing-in-action, and the amazing stories these discoveries reveal

Ralph is widely read in Smithsonian Air & Space, Military Officer Magazine, Popular Science, Leatherneck, and Veterans Magazine, and others. He is also the author of four books: "The Last Battle" (won the prestigious Colby Award), "The Last Flight of Bomber-31", "Shadow makers", and "The Early Air War in the Pacific".

Ralph's documentary efforts have appeared on NOVA, Discovery, and National Geographic Channels, including "The Last Flight of Bomber-31", "Missing in Mig Alley", and as the lead detective in "Dogfight Over Guadalcanal". He has appeared in the Military Channel series "Air Aces", featured in the segment on triple ace General Robin Olds.

A graduate of the United States Air Force Academy (USAFA) class of 1963, Ralph served three tours during the Vietnam War flying fighters in both the United States Air Force and Navy. He is credited with downing a MiG-21 during the now-famous "Bolo Mission." He flew 180 combat missions in the F-4 Phantom and A-7 Corsair, made 144 carrier landings, and later logged 1,000 hours in the F-15 Eagle.

Montana Woman Earns Champion Title!

In the summer of 2023, Britt became the 2023 US Advanced National Champion! Later, she placed 7th out of 58 pilots, making her the highest scoring American pilot. The US team placed 3rd in the world as a team.

Britt Lincoln is an accomplished competition aerobatic pilot. She began her aerobatic training and competition in 2019. She has competed in 20 aerobatic competitions and has won 14. In her first Advanced category contest, Britt placed 4th out of 24 pilots at the US National Aerobatic Championships to earn a spot on the US Advanced Aerobatic Team. She and her seven teammates, collectively the top eight pilots in the US, competed at the 2023 World Advanced Aerobatic Championships (WAAC) representing the United States of America. Britt is the only female on the US team and the first female in 15 years to compete for the United States at the WAAC.

Britt holds a 500-foot Statement of Aerobatic Competency card and made her airshow debut last summer.

Britt was born and raised on a ranch in Northern Montana. Her first flight was with her grandfather, Roger Lincoln (an FAA Wright Brothers Award recipient) when he took her up in their Cessna 180; she was only three weeks old. Eventually, her grandfather taught her to fly in their Piper Super Cub on the family's grass strip. She is a 4th generation pilot, but the first female pilot in her family. Britt's great

grandfather and grandfather were both crop dusters.

Britt holds degrees in both Accounting and German; she spent the first fifteen years of her career in the finance world. Although she learned to fly from her grandfather at a young age in the, it wasn't until November of 2017 that she obtained her private pilot

time she has since "retired" from her career in finance to pursue the world of aviation. Britt has flown approximately 40 different types of aircraft in her relatively short pilot career. Aside

from flying one of the most extreme aerobatic competition aircraft in the world, she has also flown experimentals, turboprops, and light jets. She currently holds Commercial, Multi-Engine Instrument, and Commercial Sea Plane ratings, as well as her tailwheel endorsement.

Britt serves on the Board of Directors of the International Aerobatic Club and remains a strong advocate of aviation in Montana.

Yellowstone Airport Builds New Terminal

Yellowstone Airport is in the process of constructing a new terminal building. The project planning phase began in late 2014, and will be completed in early 2025 after nearly two years of construction efforts. The building will be approximately 32,000 square feet and will meet needs that the existing terminal currently does not.

The old terminal was originally constructed in 1965. It has exceeded its planned useful life and the structure is too expensive to continue to maintain.

The new terminal is funded by 94.5% federal funds and will meet the needs of today's travelers. The increased capacity will also allow the airport to service two regional jets simultaneously.

The new terminal building will have two boarding gate hold rooms, restrooms on both sides of security, and an indoor baggage claim. These amenities currently do not exist in the original building. Due to the efficiency of modern design and construction new terminal will use less energy, despite being larger than the old terminal.

Yellowstone Airport is the last primary airport in Montana to build a new terminal, or dramatically expand an existing terminal building in recent years. It will remain the smallest primary airport terminal in the state.

Although the old terminal is slated for demolition, the original terminal sign will be relocated to the new building. Some repurposed original stonework from the old terminal will be included in the new building's accent walls. The old airport beacon will be replaced and it will be relocated to the inside of the new passenger waiting areas.




Sperry Appointed to Aeronautics Board


