

### 2024 Aviation Scholarships

Montana is fortunate to have many generous individuals and organizations who support aviation by offering scholarships to qualified persons. The Montana Department of Transportation (MDT) Aeronautics Division helps to match these scholarships to qualified applicants, and encourages individuals interested in aeronautics to apply for scholarships. The scholarships are offered to help defray costs of education (e.g., flight instruction, aircraft airframe and powerplant (A&P) mechanic school, etc.). Recipients will be announced in January 2024 and awards will be presented at noon on March 1, 2024, at the Montana Aviation Conference in Butte.

# How To Apply

To apply, complete applications must include:

- 1. Letter of application.
- 2. Biography not to exceed 250 words.
- 3. Self-portrait photo.

Application letters should explain reasons for applying, future career goals, past aviation experience (if any), and outstanding achievements.

#### Essential Reminders:

- Each document MUST include your name, mailing address, email address, and phone number.
- All three required items must be attached to the same email (or enclosed in one envelope) for each scholarship. The same letter can be used for multiple scholarships, but candidates must submit a separate copy addressed to each individual scholarship.
- We cannot accept or open Google doc files. Please attach emailed applications as .pdf files.
- Incomplete applications will not be considered
- Scholarship applications must be postmarked, or date stamped, on or before 11:59 p.m. MST, <u>November 17, 2023</u>.

# 2024 Flight Instructor Refresher Clinic

There will be a Flight Instructor Refresher Course (FIRC) happening in Helena on February 2 - 3, 2024. The MDT Aeronautics Division is organizing Aviation Seminars to provide the two-day course approved by the Federal Aviation Administration (FAA). It will take place from 8 a.m. to 5:30 p.m. on Friday and Saturday. This course fulfills the renewal requirements for certified flight instructors and includes FAA renewal.

Even if you are not a certified flight instructor, you can still attend and learn valuable information as a pilot. The cost of tuition is \$75, but if you are a registered pilot in Montana, you can get a \$25 discount. If you are not currently registered with the MDT Aeronautics Division, you can register for \$10 per year and save on the FIRC tuition.

# Are You a Pilot Who Hunts?

As hunting season commences in Montana, aviators who hunt are advised to familiarize themselves with regulations concerning the use of aircraft for hunting. These regulations aim to ensure the safety and fairness of the sport for both humans and wildlife.

Montana Fish, Wildlife, and Parks (FWP) have outlined several rules that are relevant to aviation and hunting:

- It is prohibited to locate game animals for hunting purposes on the same day that you are airborne.
- The use of aircraft to concentrate, pursue, drive, rally, or disturb any game bird, migratory bird, game animal, or fur-bearing animal is strictly prohibited.
- Spotting or locating game animals or fur-bearing animals from the air and communicating their location to individuals on the ground via air-to-ground communication, signals, or other devices for the purpose of hunting or pursuing wildlife is illegal.
- It is unlawful to kill, take, or shoot at any game bird, game animal, or fur-bearing animal from an aircraft.
- Within national forest boundaries, aircraft may only be utilized for hunting activities when loading or unloading individuals or cargo at federally approved airports, landing fields, or heliports.
- For further information, refer to the Montana Code Annotated (MCA) 87-6-208.


