# Montana Aeronautics Board Awards Funding for Fiscal Year (FY) 2025

The Montana Department of Transportation's (MDT) Aeronautics Board approved over \$3.2 million in funding during their January 2024 meeting in Helena. The requests were for a variety of airport infrastructure improvement projects.

A portion of the money awarded in grants and loans each year goes to leverage 90/10 Federal Aviation Administration (FAA) match dollars for large airport construction projects. Almost \$3.9 million of funds were requested by 44 public-use airports across the state. The Board awarded funds for 81out of 84 different project requests for 42 of Montana's public airports, to include federally and non-federally funded projects.

# Distinguished Montanan Recognized

In December of 2023, William W. "Bill" Galt was awarded the Wright Brothers Master Pilot Award to honor his 50 years of flying. Jeff Vercoe, from the Helena Flight Standards District Office, presented the award.

Bill is a third-generation Montana rancher.

Bill's love for aviation started when he was in high school when he took a 6 month vocational education class on aircraft maintenance, where he got the opportunity the take his first few flights in a Cessna 150. After high school he joined the US Army and finished his private pilot training at the Fort Knox flight club.

Bill owns and operates Galt Ranch Aviation, LLC and has served as its Chief Pilot since 2003. He currently has over 5,500 hours of flying experience, with over 4,000 helicopter hours (700 hours in the 2008 Bell 206L4). Most of his hours have been in mountainous terrain. Bill maintains a Commercial Pilot Certificate Land and Sea, Certified Flight Instructor, and a Montana Pilot Registration. He holds certificates for 135, 133, and 137 and was US Forest Service carded for many years.

He is a Bell Helicopter certified pilot and has received recurrent training bi-annually for the past twelve years from a Bell instructor. For the past 10 years, he has received mountainous terrain flight training as well as long line vertical reference and external load training.

Bill is also a member of the following organizations: Montana Quarter Horse Association; American Quarter Horse Association (Life Time Member); Aircraft Owners and Pilots Association; Montana Pilots Association; National Agricultural Aviation Association; Montana Stock Grower Association, National Cattleman's Beef Association and Montana Farm Bureau.

# Yellowstone Airport: Free Surplus Airport Fire Truck

Yellowstone Airport is looking to dispose of a Surplus Index B Aircraft Rescue and Fire Fighting (ARFF)
Truck. The truck is a 1993 E-One Titan 4X4. It was acquired from Fort Hood in 2014 and has been stored indoors since. It has a 1,500 gallon water capacity which can be discharged from the roof and bumper turrets. The other water systems and some instruments in the cockpit are not functional. The engine is mechanically sound, and the vehicle drives and runs really well. The truck must be given to a city, county, state, airport authority, or other government municipality.

# Laser Strikes On The Rise

FAA data shows that laser strikes are on a significant rise in the United States. In 2006, 384 strikes were reported. In 2023, the number of strikes reported had increased to 13,304. Montana is no exception, and has also experienced an increase in laser strike events.

The FAA may take enforcement action against people who violate Federal Aviation Regulations by shining lasers at aircraft, and can impose civil penalties of up to \$11,000 per violation. The FAA's guidance for agency investigators and attorneys stresses that laser violations should not be addressed through warning notices. The FAA seeks moderately high civil penalties for inadvertent violations, but maximum penalties for deliberate violations. Violators who are pilots or mechanics face revocation of their FAA certificate in addition to civil penalties

Laser strikes to aircraft must be reported to the FAA.

# FAA Gains Law Enforcement Officer

The Helena Flight Standards District Office (FSDO) gained a special law enforcement officer last year. The officer investigates a broad range of issues including illegal operations such as drug smuggling with aircraft.

The Helena FSDO oversees Montana and Idaho, and is responsible for airmen, air carriers, aviation maintenance technicians, certificated FAA operators, aviation safety, and more throughout the region.

The officer travels throughout the district conducting ramp checks to ensure proper documentation of airmen and aircraft in operation.

Last fall, a ramp check training was conducted by the officer for a wide cross section of law enforcement agencies across the state. Since any law enforcement officer can conduct a ramp check on a civil aircraft, this training focused on how officers can safely approach an aircraft, and what documents are required to be in possession by the pilot(s) and aircraft, and how to make reports of illegal activity to the FSDO.


