Approval of Minutes

The September meeting notes were approved as written and will be posted to the CHSP website.

Annual meeting - Take Away

The FCCLA session was good and The Blackfeet Tribe – Native American Crisis video was great. The social networking session wasn't as effective for many attendees. Many don't use social networking tools such as Facebook, Twitter, Instagram, etc. The interaction with FCCLA students during the session was beneficial. The presentation by Pat Goldhahn was powerful and much appreciate. Next year's Annual CHSP will be October 9-10-2019 at the Colonial.

An outcome from the annual meeting is a suggestion to have a coordinated and consistent messaging to be sent out to partners who could in turn push out to their networks. Planning's public involvement contact will be developing a calendar for media messaging to be pushed out to safety partners on biweekly schedule. Expectation is to see something after the first of the year.

Old Business-

National Child Passenger Safety week was September 23-29. Checkup events supported with media efforts (radio/Facebook) were conducted in 14 different locations throughout the state. Other events were conducted without media notice. Fort Peck SOAR /CPS coordinator conducted 5 separate events. The BUMT coalitions each hosted at least one event. Mary Kay Burns, Cascade Co BUMT successfully applied for a Graco grant and received 25 car seats that were to be distributed in September. Graco also sent CPS technicians to Montana to help with distribution during National CPS Week.

Hannah Yang is working on a white paper summarizing the Medicaid costs for unbelted motor vehicle occupants. She hopes to have it finalized soon. Once completed Pam Langve-Davis will set up a meeting with management to review and determine next steps.

New Business-

Rotunda Day is scheduled for January 29, 2019 for the Occupant Protection Safety Day. Meeting discussion revolved around brainstorming ideas. A lead on this strategy was not named. Coordination among safety partners is needed. Event coordination will be discussed/decided at the December 11 meeting.

Impaired Driving – A Crisis in Tribal Communities a video was developed by the Blackfeet Tribe using FHWA Tribal Transportation Safety Program (TTSP) funding with some funding by MDT. Blackfeet SOAR Coordinator Eileen Henderson worked closely with Wendt Agency on the video.

Next step is distribution. Currently it is on YouTube https://youtu.be/rrjM5KAct8U?list=PLxseor611x1EFt8kpwT4LoBp6wpvTsTjc and SOAR Face Book. Other possibilities include PBS, local television, movie theaters, IHS, etc.
