- 1. Understand SC feedback from 8/24 meeting
  - a. Liz and Brian walked through the SC coordination and responses to remaining 4 questions
    - i. Only show a % range for Final Analysis Map not individual NAC maps or District maps
    - ii. Add logos to tool landing page and bottom page (contacts)
    - iii. Updates to existing data to be done as scheduled (annually) by DI do not need SC approval
    - iv. Any new data or information to be added to the tool should be brought to SC for approval anticipated 5-year intervals or as needed if deemed critical by DI
    - v. Fine scale assessment is loosely defined in the selection criteria and application guidance which will be available to the public
  - b. Liz introduced the Draft SC Communication Plan for roll out of the Tool and Application Process to interested stakeholders and the public. More to come on this.
    - Coordination of the plan with the agency public information officers and MSWP communication representative is needed by mid-October.
    - ii. Goal to release Tool and Application Process by early November
    - iii. First application cycle is planned for May 2023
