    - 1. **Consider one cycle ahead instead of one year – November 2025**
      - a. **Time delay due to backlog of bigger projects and FY ceiling (\$500K) on FS money**
    - 2. **November small projects (based on FY FS reserve)**
    - 3. **May 2026 restrictions expected? Need to decide soon**
  - b. Review/review Charter
    - i. Discuss individual comments
    - ii. Clarify roles and commitments of the partners to support these projects.
      - 1. **Reviewed in meeting and edits/comments made by members**
      - 2. **Finalize Charter revisions at the next meeting**
