II. NEW BUSINESS

- a. MDT SC member transition – RS – **Rob stepping officially away from MWTP – RS will be doing policy so he will stay in loop – more involved in fed and state policy as well as internal policies too. Will aim to develop consistent messaging RE wildlife crossing structures. Dustin will be doing his similar work in project development and delivery, bringing Environmental back under Engineering. DR is joining the steering committee. RS may sit in meetings on occasion.**
- b. Recap of MWTP SC meeting in Helena
 - i. Takeaways – **Come back for next meeting with a few key things**
 - ii. Review and approve of Deb and others notes shared with the SC - **approved**
 - iii. Discuss timeline and action items regarding:
 - a. funding plan (US 191 – Mouth of Canyon and other projects in the hopper)
 - **Talked about project planning and need for focusing on future funding for the current projects. Updates -**
 - **Discussion about STIP – comments would carry more weight if from MSWP as a coalition, rather than individual NGOs. Ideally information and “needs” would be frontloaded ahead of project nomination phase, rather than after a project has been identified and included in the STIP.**
 - **Let’s brainstorm how partners and wildlife considerations can be proactive rather than reactive to have it in nomination phase, project planning, or very early in project development.**
 - **For load-posted bridges – WTI/Marcel western MT study will include on-system LP bridges**
 - Any nuggets in funding whitepaper Brooke Shifrin developed back in 2020 (?) - **not discussed**
 - What updates can be made to this document to help in the development of a funding plan as discussed in Helena?

MSWP ideas for prioritization approach and methodologies, examples – KP – **discussion of prioritization approaches – plan with implementation frameworks – MDT noted the value of unified prioritization map and guiding document and clarity of pathways. Kylie will put docs into the Teams workplan folder. Everyone please review it and communicate for each question the best choice(s) and any problem/show-stoppers (green light/red light), with the intent to narrow down the best options. Complete by July 15 for Kylie to consolidate in time for next meeting (shifting to early Aug). Have this document effort be the next meeting focus.**

Currently thinking that applications will be open all year, but SC review and selection of projects will occur once a year in November.**
