August 20, 2025

II) NEW BUSINESS

- A) Planning Tool updates from D&I Work Group – **Brian Klapstein (MDT GIS) and DW gave updates on the tool. Brian presented a power point which has been uploaded to Teams: [2025 Planning Tool updates.pptx](#)**
Major updates include:
 - **ALTIS Maturity**
 - **NAC 1 – added FWP carcass salvage data, updated crash, carcass, traffic data**
 - **NAC 2/3 - moved wolverine data from NAC 2 to NAC 3 as now federally listed as threatened; SOC list updated**
 - **NAC 4/5 - no notable changes**
 - **All NAC reweighted, NAC 1, NAC 2 and NAC 3 layers within NACs reweighted**
 - **New reference data was made available in web map (e.g., wildlife accommodation locations, load posted and scour critical bridges, SO3362 priority areas and highways of interest for wildlife movement)**
 - **MDT server was upgraded – better performance and reliability**
 - **Tool migrated to new ArcGIS Experience Builder**
 - **Simon suggested making the updates to PT more prominent on the MWTP webpage**
 - **Tom expressed some concern over the down-weighting of NAC1 – reevaluate as only AVC/safety metric among 4 more conservation-based metrics**

- Tom requested ability to apply separate filters for each NAC – may be possible but may take a little work to make available
- Updates to the Planning Tool Summary Report and Help Guide needed

D) **Project Funding Plans**

- 1) Phase IV for US-191 Mouth of the Canyon
 - (i) Federal funding/grants -
 - **Deb reported on a FHWA WCPP debrief on this previous application. Project received the highest scores in each of three categories. Was a matter of spreading the awards across states, and more applications received than funding available. Recommended to resubmit when NOFO is announced. 2025-2026 NOFO was due out in May 2025 but didn't happen. It is expected to happen at some point, but not imminent.**

- **Be ready to submit – Partnership has asked MDT to make this project the only priority for the WCPP grant in 2026.**
 - **Can MDT commit to support? Tom believes so and will get the conversation started.**
- **FHWA indicated good bipartisan support for continuing/expanding WCPP in congress. Hopeful...**

- **Committee and staff will only review project applications one time a year. We are going with April (submissions due by April 30), review and selection to occur in May and June.**
- **Smaller (e.g., no feasibility study needed) projects can be reviewed at any time they received.**
