- o DPHHS/EMS project proposal continued from last meeting
 - NEMSIS 3.5 upgrade project
 - USDOT provide \$'s and guidance for state EMS
 - NHTSA EMS has a national registry as a single source for EMS data
 - First year agencies will work with DPHHS learning and updating to new NEMSIS version 3.5
 - Second year get EMS agencies using upgrade and aiming for 24 hour data reporting. MT currently has 80% reporting in 48 hours

- EMS has been the most reliable data source for covid and drug calls
- DPHHS looking for funding to upgrade software at the 125 EMS agencies, upgrade mapping and data elements, training for EMS agencies with new data elements and reporting, aggregate and analyze new data elements, DPHHS capacity to incorporate new data elements into existing reporting back to EMS agencies.
- Janet Kenny asked for a ballpark cost of project, and would this be a FF2023 project. Answers - \$175,000 + \$200,000 + \$25,000 + \$40,000 = \$440,000 and yes. MDT will be sending this project to NHTSA soon.
