#### **EXECUTIVE SUMMARY/MAJOR ACCOMPLISHMENTS**

This First Quarterly Report is submitted to the Montana Department of Transportation (MDT) and the U.S. Department of Transportation, Federal Highway Administration (FHWA) to provide details on the activities and project work of Montana LTAP in support of MDT Project No. 02443, Montana Local Technical Assistance Program, during the period July 1, 2017 through September 30, 2017.

Highlights of Montana LTAP's accomplishments during that period include the following:

- ➤ During July 2017, the LTAP Advisory Board met to discusses the LTAP training agenda for 2017-2018, work plan, and LTAP program.
- ➤ Matthew Ulberg and Genevieve Houska attended the National LTAP Annual Conference in Norfolk, Virginia, July 17 21, 2017.
- ➤ LTAP hosted three monthly safety webinars during the first quarter. Summer Safety, Defensive Driving, and Trenching and Excavation Safety were the topics covered.
- ➤ Matthew Ulberg participated in the FHWA Peer Exchange in Lincoln, Nebraska, August 22 23, 2017 and attended the MDT Highway Rail Conference in Helena, August 29 30, 2017.
- ➤ Shawna Page conducted a First Aid class for the City of Hamilton August 28 29, 2017.
- > Two flagger certification classes were conducted during the first quarter.
- ➤ LTAP participated as a vendor at the Montana Association of Counties and the League of Cities and Towns annual conferences during September 2017. LTAP would like to grow its training base at the transportation safety workshops and open more opportunities to work with Montana counties, cities, and towns.
- ➤ The 28<sup>th</sup> Annual Snow Rodeo was held in Bozeman at the Gallatin Valley Fairgrounds September 6 and 7, 2017. Training tropics included Leadership and Load Securement.

This progress report is organized following the four LTAP focus areas:

- 1. Safety
- 2. Infrastructure Management
- 3. Workforce Development
- 4. Organizational Excellence

#### 1. SAFETY

#### **Past Activities**

Proactive safety training initiatives for local governments are key objectives in this focus area. Technology transfer is accomplished through safety-related articles in LTAP's quarterly newsletter, safety training seminars, staff responses to phone and email inquiries, and on-site technical assistance. In the projected LTAP budget, 48 percent of funding is allocated to the Safety focus area. Table 1 shows the safety focus area budget and costs-to-date.

Two safety related workshops were conducted during this three-month period. A total of 16 participants attended. The workshops included:

- Two Flagger Certification classes were conducted during the 1<sup>st</sup> quarter. Topics included flagging duties and responsibilities; and safety, uniformity and liability issues.
- Summer Safety webinar was conducted, July 27, 2017, and Trenching and Excavation Safety was conducted on September 19, 2017. The webinar recordings can be accessed via the LTAP website link:

## **Challenges**

- Cattle Guards, MSHA Part 46, and Excavation Safety are classes that have been requested on LTAP workshop evaluations forms. Most of the requests are from eastern Montana. The MACRs fall series of trainings will address some of the needs identified.
- There is a greater demand for these classes in the rural portions of Montana compared to the larger metropolitan areas. When delivering a recent training, it was noted that many in eastern Montana have not had the 3-day MSHA Part 46 new miner training, and as such we are developing this class as rapidly as we can to deliver it in February of 2018. This is a key area of program development that is driven by the needs of our Counties.

• Missoula County and other larger counties are relying on in-house training, and present a challenge for us to serve them in a meaningful way.

## **Planned Activities**

- ➤ Flagger Certification workshops are scheduled for October 24, 2017 in Billings and November 13, 2017 in White Sulphur Springs.
- A First Aid training workshop is scheduled for Lewis & Clark County and the City of Helena on October 30, 2017 in Helena.
- ➤ Winter Maintenance and Safety workshops are scheduled for November 28 30, 2017 in Helena, Billings, and Glendive.
- ➤ MSHA Part 46 workshops are scheduled for Great Falls, Bozeman, and Billings in February 2018. These will be three-day classes in each location to cover the 24 hours of training need for this certification.

## 2. INFRASTRUCTURE MANAGEMENT

#### **Past Activities**

Montana LTAP is promoting Cattle Guard Specifications, MSHA, and Excavation Safety at the MACRS Fall District Meetings across the state of Montana. The training sessions will provide training in the projected LTAP budget, 18 percent of funding is allocated to the infrastructure management focus area. Table 2 shows the infrastructure management focus area budget and costs-to-date.

#### **Challenges**

- Intersections on county rural roads are becoming more of a concern due to the number of increasing crashes. There is a demand for training in culvert installation, trenching safety, cattle guard installation, and sign management.
- Some counties have expressed an interest in an inventory management system. This is a good option for a MACRS training.




Figure 1: Summary of Annual Workshop Locations for 1st Quarter 2017–2018.
