The Montana Department of Transportation plans to replace the current bridge over the Flathead River on Montana Highway 82 near Bigfork, also known as Sportsman's Bridge, with a new bridge that is safer and better able to handle the increased traffic in the area. The new structure will feature two 12-foot travel lanes and two 10-foot shoulders, both wider than the current dimensions. It will be constructed adjacent to the south side of the current bridge in order to maintain traffic on the existing bridge during construction. A new Sportsman's Bridge Fishing Access Site (FAS) will also be constructed in its current location on the east side of Flathead River, as well as new left- and right-hand turning lanes on Highway 82 at the intersection with Hanging Rock Drive.
