
Dear Gallatin County Neighbors,

US Highway 191, between Big Sky and West Yellowstone, is deteriorating. The asphalt needs to be repaired.

To ensure this roadway remains safe and smooth for years to come, the Montana Department of Transportation (MDT) and Riverside Contracting will complete the Highway 191 – North of West Yellowstone project.

23 MILES OF IMPROVEMENTS WILL INCLUDE:

- Repaving Highway 191 from Tepee Creek Trailhead to US Forest Service Road 986 - between Big Sky and West Yellowstone.
- Creating a northbound left-turn lane at Rainbow Point Road.
- Repairing bridge crossings over Specimen Creek and the Gallatin River.
- Replacing old guardrail with new rail.
- Adding rumble strips.





Work is expected to begin in early May and last through August 2020. Traffic will be limited to one-lane during construction. Drivers can expect delays of up to 15 minutes in each construction zone. Wide loads will be restricted. Trucks carrying loads wider than 11 feet should use an alternate route.

The Montana Department of Transportation together with its construction contracting partners are taking the COVID-19 pandemic very seriously. Construction projects on Montana's roads and bridges are considered an "essential" operation and will move forward as scheduled in 2020. While construction workers traveling to a worksite are exempt from the 14-day self-isolation travel rules, several measures have been implemented to help keep employees, contractors and the public safe during the construction season.
