



James K. Coyne to Kick-Off 25th Annual Aviation Conference

James K. Coyne, president of the National Air Transportation Association, will be the featured speaker at the Aviation Conference kickoff luncheon Thursday, March 5. Coyne holds a B.S. degree from Yale and an M.B.A. from Harvard. He has a distinguished career as a Representative in the U.S. Congress, a member of the White House senior staff, successful businessman and teacher. For the past 35 years, Coyne has been an active pilot with instrument and multi-engine ratings.

After leaving the White House in 1985, he worked as a consultant and association executive. He served as president of the American Consulting Engineers Council, founder and president of the American Tort Reform Association, founder and president of Americans to Limit Congressional Terms and wrote two books on Congressional reform. He was the director of numerous private and public corporations including the Association of Former Members of Congress.

Coyne's love for and commitment to aviation has been an important facet of his professional and private life. Two business airplanes helped him to expand his business significantly in the 1970s. He also regularly flew from Washington to Pennsylvania during his term in Congress. As NATA president, Mr. Coyne visited over 800 FBOs and aviation service businesses across the country. He also regularly presents the viewpoint of the industry before Congressional committees, the FAA and other federal agencies.


Coyne lives in McLean, Virginia with his wife, Holly, an instrument-rated pilot. He has three children, Sandy (also a pilot), Kate and Michael, and four grandchildren.

Given this is the 25th aviation conference, the committee is making sure it is one to remember. Expect new and exciting speakers. Plus, the exhibit hall will be packed with vendors including the Federal Aviation Administration's Gyro-2, a spatial disorientation simulator.

On Friday, March 6, a spouse/guest tour will be offered after lunch of the Moss Mansion Historic House Museum. The tour captures early turn-of-the-century life as the Preston Boyd Moss family lived it. Visitors see original draperies, fixtures, furniture, Persian carpets and artifacts displayed in the 1903 red sandstone structure. The Moss Mansion was designed by the New York architect Henry Janeway Hardenbergh who also designed the original Waldorf Astoria, Plaza Hotels, Williard Hotel and Copely Hotel. The home is listed on the National Register of Historic Places.

Friday afternoon Rocky Mountain Aviation Department will open their doors for a tour of their facility and the Rocky training fleet. The Montana Pilots Association will also hold their hospitality event during this time. Transportation will be available to the Friday afternoon events.

Administrator's Column

Essential Air Service Update: For the past 11 months residents and visitors to Glasgow, Glendive, Wolf Point and Havre had not been able to fly commercially since the demise of Big Sky Airlines in March 2008. The EAS contract was awarded to Great Lakes Aviation of Cheyenne, Wyo., who announced it will begin service between these communities and Billings on February 1. Sidney and Lewistown service to Denver returned on September 3 and Miles City to Denver resumed on October 26. The service will begin with one flight per day in a Beechcraft 1900 aircraft. Sidney will get a third daily flight to Billings in addition to its two Denver flights. The Transportation Security Administration will be ready with equipment and personnel at these four airports. Appointments: **Steve Bernett** has been named Acting Regional Administrator for the FAA Northwest Mountain Region, replacing Dennis Roberts who has accepted a position in Washington DC. Steve will serve until the FAA completes its hiring process and comes to the northwest from the FAA Logistics Aeronautical Center. **Lynne Osmus**, of Virginia, has been named by President Bush as the Acting Administrator of the Federal Aviation Administration. Lynne is currently the Assistant Administrator for Security and Hazardous Materials at the FAA and has held numerous positions with the FAA. She is the FAA's liaison with the Obama transition team and served as chief of staff to former FAA administrators David Hinson and Jane Garvey. **Rep. Ray LaHood, IL** has been nominated to serve as Transportation Secretary by President-elect Obama. Rep. LaHood served on the House aviation subcommittee in 2000 and was noted as a strong GA advocate. He also has been a proponent for improving local airports and increasing air service in his home state of Illinois.

TSA Light Aircraft Security Program: The TSA has proposed a new set of rules "aimed" at increasing the safety and security of our airways. The new rules extend to general aviation many of the rules that now apply to commercial airlines. The rule affects aircraft exceeding a maximum take-off weight of 12,500 pounds and would require these operators to: submit passenger names to a third-party provider for screening against the terrorist watch list; and to contract with third-party auditors to assess their security plans. The fear of the gross take-off weight being eliminated in the future together with other concerns has drawn strong opposition to the proposal from the GA community at TSA public hearings in major cities around the country. No hearings were conducted in or close to Montana. To view the proposal and to submit comments, visit: www.regulations.gov; search for Docket No. TSA-2008-0021. Comments are due February 27, 2009 and can be submitted electronically, by mail or fax.

TSA Proposes Rule that Targets General

AOPA is asking the aviation community to make its voice heard with comments on the Transportation Security Administration (TSA) proposed rule that targets general aviation. The TSA has released its Notice of Proposed Rulemaking (NPRM) entitled Large Aircraft Security Program (LASP).

AOPA members have made it clear in a survey and in comments to the Association that they are concerned by the attempt to make GA aircraft over 12,500 pounds flown under Part 91 comply with the same security requirements as commercial carriers. This proposal includes a number of initiatives: flight crew member criminal history record checks, watch list matching of passengers, checking passengers and baggage for dangerous weapons and biennial third party audits of each aircraft operator. In summary, the proposed rule represents an unprecedented intrusion on general aviation because it would apply commercial standards to GA operations. AOPA also is concerned about the proposal because the TSA has provided no justification for setting the aircraft weight requirement at 12,500 pounds. The Association fears it could expand to all sizes of GA aircraft. Equally alarming is a requirement that aircraft operators use and pay for third-party auditors to perform a government function.

The TSA will be holding a series of public meetings to hear how the proposed rule will impact GA. The meetings – which will begin at 9 a.m. local time (with registration starting at 8 a.m.) – will be held at the following locations: Burbank, Calif., **Jan. 23, 2009**: Burbank Airport Marriot Hotel & Convention Center, 2500 North Hollywood Way; Houston, Texas, **Jan. 28, 2009**: Hilton Houston Hotel-North Greenspoint Conference Center, 12400 Greenspoint Drive. Hearings have already been conducted in White Plains, Atlanta and Chicago.

Each speaker will be allowed three minutes to explain to TSA the impact of this rule. A representative from AOPA will be attending each meeting to discuss this proposal with members.

Your voice can make a difference, show up and explain to TSA just how the proposed LASP will impact your flying. If you cannot attend, it is still important that you make your voice heard by submitting comments to the official docket. Historic Registry Plaque Dedicated at Cut Bank Airport

Life is full of coincidental events. When a group of 35 folks met on December 9 to celebrate the historic listing of the Cut Bank Airport and WWII Air Force Base; that fact was brought to their attention by Bob Jacoby, historian for the WWII Airmen's Memorial Museum.

Mr. Jacoby related that Dec. 7, 1941 was on a Sunday. This year, December 7, which is the 67th anniversary of the attack on Pearl Harbor, also came on Sunday. On December 8, 1941, war was declared on Japan by the United States. On that same date, the Glacier County Commissioners offered the use of the Cut Bank Airport to the federal government for the war effort. Then, on Dec. 9, 1941, the commissioners received word from General Hap Arnold, accepting their offer. So, it seemed fitting that on Dec. 9, 2008 a gathering was held on that very same property to celebrate the listing of the base and the entire airport compound on the National Register of Historic Places. Guests included members of the WWII Airmen's Memorial Museum, Glacier County Commissioner and airport board member, Ron Rides at the Door, Dennis Seglem, Director of the Glacier County Historical Museum and other history enthusiasts.


Listing on the National Registry is important to help preserve the history of the location and it could also open avenues of funding to help restore and preserve the remaining historic structures. This is also the first time in the State of Montana that an entire district has been listed on the Registry.

The plaque which is currently inside the administration building will be moved to an outside spot where it can be viewed by visitors interested in the former Army Air Force Base. Signage will also be located on the highway to help direct traffic to the registry plaque and the historic buildings plus the Airmen's Memorial Museum.

Improvements are continuing on the Armament building which sustained wind damage earlier this year, and funding is being sought for both this structure and the Recreation Building which also suffered extensive wind damage. State money has been designated for improvements on the historic hangar which is still in active use today and once housed B-17 aircraft.


The dates for the conference are March 5-7. The Mechanics Seminar will be held on Friday, March 6 and continue through Saturday, March 7.


Montana pilot registration provides the Division with valuable information used for air search and rescue, and we are pleased to be able to offer pilots various safety and education programs throughout the calendar year. For a complete description of MDT Aeronautics Divisions functions, please visit our web site at: www.mdt.mt.gov/aviation/.

Montana based aircraft owners; if you have not yet submitted your 2009 aircraft registration, please do so as soon as possible. The Division is mandated by Montana law to account for Montana aircraft no later than March 1 of each calendar year. It is most important to note that according to statute, aircraft that are not registered by the March 1 deadline must pay a penalty of five times the fee, plus the fee. A newly purchased aircraft must be registered within 30 days of entering the state or it is also subject to the penalty fee.

There are exemptions to the aircraft registration. There is no fee charged for an unflyable aircraft, sold aircraft or dealer "inventory only" aircraft.

You must, however, indicate the status of each aircraft on the invoice you receive and verify that the aircraft information is correct by signing and sending it back to us.
