Meeting purpose: Progress on strategy implementation

Progress Updates

Strategy 1 - Access to the Emergency Response System; On Scene Care Training & Education

- S1.1:Continue development of the Enhanced 9-1-1 & FirstNet & Next Generation 911 access for first responders

 Measurement needs to be reconsidered and may need to be revised to be about "communication w/ First Net to learn
 more about expanding... "Need to look for a DOJ contact. Mark Keeffe shared that MHP is testing ability to "hot spot"
 to vehicles to identify a cell phone carrier that can connect and provide WiFi for emergency responders.
 - > Janet Trethewey has a contact and will reach out for information.
- S1.2:Support Emergency Medical Dispatch (EMD) training for all dispatch centers
 Shari Graham reported training program at MLEA is ongoing. Looking for backup trainer for Dayle Perrin. Training course is scheduled at Malmstrom AFB. Struggling w/communication w/ King Co. not responding.
- S1.3:Support bystander/ nonemergency personal training and education, (I.E. Stop the Bleed, First Aid, etc.).

 Instead of measurable being ePCR the team recommended updating the measurable to "track number of training courses held & number of class participants". Ex: Red Cross & other first response. In 2020 there were a 248 bystander use of AED &/or CPR, (Reference: 2021 EMS Annual Report, page 61, Table 26).
 - > Janet Trethewey will research programs for consideration to report classes/ participants.

Strategy 2 - Safe & Rapid Transport of Crash Victims and Training of Emergency Responders

- S2.1:Support ongoing education and training of emergency care responders.
 Prehospital Trauma Life Support (PHTLS)- MDT Grant: 8 courses (FY 2020-21) / 75 students via mobile SIMS. Received confirmation of FY2022 grant cycle funding. 8 agencies requested funding. Courses to begin in Nov 2021.
- S2.2:Secure EMS equipment and training to properly restrain and care for children (EMS for Children)- No report.
- S2.3:Support and promote MDT Emergency Medical Equipment Grant Program
 FFY 2022: 7 EMS-MDT Grants awarded (5 ambulances)
- S2.4:Promote and improve prehospital notification communication system with facilities
 Research is ongoing best option to pre-hospital to notifications. Further discussion needed.
- S2.5:Support and promote Trauma Emergency Response training for Law Enforcement Officers (LEO) & Equip Law Enforcement vehicles with basic trauma kits
 - The process to incorporation an 8-hour Pre-Hospital Trauma Life Support for First Responders (PHTLS-FR) course in the Law Enforcement Academy training requirements is under review and needs to be revisited.
 - > Janet Trethewey will double check names of trainers out at the Advanced Academy at Boulder.
- S2.6: Support and promote Traffic Incident Management Systems (TIMS) Training

Strategy 3: Hospital-Based Trauma Care

• S3.1:Support ongoing education and training of the trauma team.

ATLS: 3 of 5 trainings scheduled for 2021 have been held, as well as an instructor course.

TEAM Grant: FFY 2021: 9 TEAMs courses held this grant cycle; Eastern Regional Trauma Advisory Committee (ERTAC): 5 of 6 courses scheduled; Central Regional Trauma Advisory Committee (CRTAC):2 of 3 courses scheduled, Western Regional Trauma Advisory Committee (WRTAC): 2 of 3 courses scheduled. FFY2022: Received funding notice for 12 Team courses.

- S3.2:Support and further trauma center designation for all Montana facilities that care for injured persons

 Currently 43 of 65 are designated centers (Confirmed by Alyssa Johnson). Trauma Center designations are continuing with

 13 designations and 6 focus reviews completed to date and others scheduled to be completed before years end.
- S3.3:Support and further Pediatric Ready Recognition for all Montana facilities- No report.
- S3.4:Continue to support and promote the Rocky Mountain Rural Trauma Symposium (RMRTS)
 2021 Virtual RMRTS scheduled & in process, began Sept 27 w/11 presentations over 3-week course with 300+ registered.

Strategy 4- Integrate Crash, EMS, Trauma and Roadway Surveillance

- S4.1:Continue to utilize and enhance ImageTrend data (EMS patient care records) to track road safety trends and to improve overall EMS system performance.
 - 2021 EMS Annual Report finalized. Ten (10) data requests received through DPHHS online form. 8 of 10 have been requests for EMS data. 7 of the 8 EMS-related data requests have been fulfilled.
- S4.2:Utilize ESO/Digital Innovations (DI) data (Trauma Registry) to analyze hospital treatment of the patient and implement performance improvement using the data.
 - Carol Kussman reported that the New Driller Module was successfully rolled out to trauma centers with scheduled web-based data to include national data elements. Virtual training and assistance will be available to trauma centers over the next year.
- S4.3:Continue to support and use available Montana Highway Patrol (MHP) motor vehicle (MV) crash data for analysis to guide injury prevention strategies and emergency care of the patients.
 2020 Crash Data- Fatalities: 212 Serious Injuries: 730. Crash factors will be reported at the 2021 Annual Transportation Safety meeting and posted to the CHSP website following the meeting.
- S4.4:Integrate ImageTrend, DI and MHP data sets (via Biospatial platform among others) to provide a full picture of crash injuries in Montana.
 - Work continues towards linking 2020 EMS and Trauma registry data in-house for the purpose of publishing an annual report for the trauma program. DPHHS published a seat belt fact sheet 2021 which includes data from various sources https://dphhs.mt.gov/assets/publichealth/2021 Seatbelt Factsheet ADA.pdf
- S4.5:Utilize Dept. of Labor & Industry data to further understand first responder crash injuries There were 4 injuries in the second quarter of 2021.

Strategy 5- Provide Statewide Injury Prevention Education to Communities Through A Collaborative Effort

- S5.1: Provide guidance, support, coordination, and technical assistance to local and regional injury prevention activities. Aug 2021: CORESUP received & transportation forums planning process started. Review of County Health Plans is anticipated before years end.
- S5.2:Integrate MDT Comprehensive Highway Safety Plan (CHSP) & DPHHS State Health Improvement Plan (SHIP) strategies.
 DPHHS & MDT staff are participating team members on the SHIP & the CHSP Emphasis Area groups involved in coordinating, communication, and collaborating on joint activities. Montana Crash data is posted online at https://www.mdt.mt.gov/visionzero/plans/chsp.shtml

Strategy 6- Support Laws, Policy Development and Legislation

- S6.1: Support activities surrounding policies and regulations that provide for emergency care access, EMS, facility
 designation and care standards.
 - Meeting planned in November to discuss next steps in county injury prevention plans
- S6.2 Support state law and enhance driver awareness of Montana's Mover Over Law, including tow operators and vehicles.

 Law enforcement needed to engage and provide input on support to law enforcement and associated activities.
